- Salary: This is a voluntary role. Expenses will be covered.
- Location: Flexible, but with the expectation to attend in person meetings in Glasgow or Edinburgh at least 4 times a year.
- Reports to: The **basketball**scotland Chair.
- Time Commitment: approximately 1 day per month:
  - Attendance at 8 10 meetings per annum (including Board meetings and AGM, generally lasting 1 – 3 hours)
  - Involvement in Board working groups
  - Additional requirements as necessary

- To make an informed contribution to the strategy and objectives of **basketball**scotland, offering a view to the organisation in an objective and constructive manner
- To take shared responsibility for the performance of the organisation, monitoring performance to ensure **basketball**scotland achieves its objectives and aims, operating as a high performing organisation
- To represent basketballscotland externally with excellence, promoting the work and values of the organisation
- Help connect the organisation and board with networks of potentially useful people and organisations
- Knowledge, expertise and influence relevant to **basketball**scotland's affairs
